

## Minutes of Wapiti Corridor Planning Society Board Meeting

3. Floor was opened for discussion.  
Points discussed:
  - All parties to the plan were notified by letter of the change to the plan and the revised boundaries. Includes AESRD, County of GP, City of GP, MD of Greenview, various stakeholders.
  - Board reviewed, at length, if MD of Greenview should have a non-voting member on the board. Bylaws allow for a non-voting member. Communication is still important with the MD, send information to the MD and information on WCPS website will keep MD informed. Leanne Beaupre also liaisons with MD and WCPS for additional information sharing. **Board decision not to have a member of the MD on the Board.**
  - Wapiti Watershed – WCPS to have a member on their board. Duane Stevenson is currently in that position. Information from the Watershed group is highly scientific at this point, however WCPS wants to be informed if any information is useful for land use and its affect to the WCPS plan.
  - Dan Wong provided update to the bylaws. Review changes to bylaw sections. Motion to approve revised bylaws. Wayne Roznowsky made motion, seconded by Duane Stevenson.  
**Carried.**
  - The WCPS requested funding for the plan rewrite from the MD of Greenview due to the option #4 decision at the January 29 meeting, based on the MD's representation on the board and its subsequent withdrawal from the board. The requested funding from the MD is for the amount of \$10,000.00. **There has been no response yet from the MD.**
  - County of Grande Prairie has supplied \$10,000 and the City of Grande Prairie has \$5000 pending for WCPS operating funds.
  - WCPS has a seal for society status. Tom Turner is in possession of the seal.
  - Website changes will continue to be handled by the county of GP.
  - Dan Wong and John Simpson have given their resignation from the Board.
